- **Position:** Junior Research Fellow (JRF)
- Number of Positions: One (01)
- Emoluments:
 - Rs. 37000/- per month for two years (JRF) and 42000/-month (one year) plus admissible HRA @16% (For NET Qualified Candidates)
 - Rs. 31000/- per month for two years (JRF) plus admissible HRA @16% (For non-NET qualified candidates)
- **Project Duration:** 3 years (subject to annual performance review)

Eligibility Criteria

Essential Qualification:

• M.Pharm/M.S. (Pharm)/M.Tech/M.Sc in Pharmaceutical Sciences, Pharmaceutical Chemistry, Medicinal Chemistry, or related disciplines with at least 60% marks (or equivalent CGPA).

Desirable Qualification:

- **Research experience** in drug discovery, computational chemistry, molecular modeling, or synthetic medicinal chemistry is highly desirable.
- **Programming skills** in computational drug design (Python, C++, or molecular modeling software) will be an added advantage.
- Scholars who have qualified NET/GATE/GPAT will be given preference.

- 3. A one-page Statement of Research Interest (SOR)
- 4. A copy of a valid NET/GATE/GPAT certificate (if applicable)
- 5. One referee's name, affiliation, email, and mobile number

Selection Process

- Shortlisting: Candidates will be shortlisted based on merit, research experience, and project requirements.
- Interview: Only shortlisted candidates will be contacted via email for an online/personal interview at UPES, Dehradun.
- No TA/DA will be provided for attending the interview.
- **PhD Enrollment Opportunity:** The selected candidate will have the opportunity to enroll for a **PhD at UPES**, subject to fulfilling university requirements.

Important Notes

- 1. The position is purely **temporary and co-terminus** with the project duration. Under no circumstances regularization of the services of the concerned appointee in the university within the sponsored project framework will take place.
- 2. The university reserves the right to **shortlist/reject** applications without assigning any reason.
- 3. Incomplete applications or applications without required documents will **not be considered**.
- 4. Age relaxation is available as per **Government of India norms** (for SC/ST/OBC/Women/PwD candidates).
